Therefore, defendant is to pay restitution in the amount of \$35,655.81, which is due and payable immediately to the Clerk of Court for the Western District of Wisconsin for disbursement to the victims listed in Attachment A, attached hereto. Further, it is ordered that over the period of his incarceration, defendant shall make payments of either quarterly installments of a minimum of \$25 if working in a non-UNICOR position or a minimum of half of his monthly earnings, not to exceed 75% of his monthly earnings, if working in a UNICOR position.

In all other respects, the judgment and commitment order remains as entered on June

10,2005.
