Defendant Allen Ladd has filed a motion pursuant to 18 U.S.C. § 3582, seeking a modification of the amended sentence imposed upon him on December 20, 2005.

My review of defendant's file shows that he was found guilty at trial of possessing more than five grams of cocaine base (crack cocaine) with intent to distribute it, in violation of 21 U.S.C. § 841(a)(1). At sentencing, defendant was determined to be a career offender as defined in U.S.S.G. § 4B1.1(a). Unfortunately for defendant, the amendment to the guidelines does not apply to him, because his sentence was determined by his status as a career offender and not by drug quantity. Therefore, I must deny his motion for a sentence reduction.

## ORDER

IT IS ORDERED that defendant Allen Ladd's motion for a sentence reduction under

## 18 U.S.C. § 3582 is DENIED.
