Upon receipt of plaintiff's partial filing fee in the amount of \$1.48, the Court addresses the merits of plaintiff's complaint. According to 28 U.S.C. § 1915(b)(2), the institution's financial officer is authorized to deduct monthly payments from plaintiff's account until the \$350.00 filing fee is paid in full.

Plaintiff alleges that in 2005 while he was incarcerated at the Wisconsin Secure Program Facility he assisted Eunice Powe and her lawyers in a wrongful death suit against the Wisconsin Department of Corrections. He alleges that defendants J. Huibregtse, Captain Gilberg, Linda Hoddy and Monica Horner retaliated against him for his actions by interfering with his mail. He further alleges that defendants Sgt. Cook and Gary

Boughton brought false disciplinary charges against him in retaliation for his assistance to Eunice Powe. Petitioner also alleges that defendants Trumm, Ellen Ray and Beerkircher retaliated against him by denying his grievances.

Petitioner may be able to support a set of facts that support retaliation claims against defendants J. Huibregtse, Tim Gilberg, Linda Hoddy, Monica Horner, Sgt. Cook, Gary Boughton, Ellen Ray, Kelly Trumm and Christine Beerkircher. He will be allowed to proceed on these claims.

Petitioner has not alleged facts that support any other claims or claims against defendants Peter Huibregtse, Richard A. Schneiter, Sandra Hautamaki, John Ray or Matthew Frank. These claims and defendants will be dismissed.

ORDER

IT IS ORDERED that plaintiff is allowed to proceed on his retaliation claims against defendants J. Huibregtse, Tim Gilberg, Linda Hoddy, Monica Horner, Sgt. Cook, Gary Boughton, Ellen Ray, Kelly Trumm and Christine Beerkircher.

IT IS FURTHER ORDERED that the remaining claims and defendants are DISMISSED.

The summons and complaint are being delivered to the United States Marshal for service on defendants J. Huibregtse, Tim Gilberg, Monica Horner, Sgt. Cook, Gary Boughton, Ellen Ray, Kelly
