In response to this court's January 12, 2005 order, each of the four petitioners in this group action has advised the court that he wishes to remain a party to the lawsuit. Petitioner Dondra House has requested and received an enlargement of time to March 8, 2005, in which either to pay the \$150 fee he owes for filing his claims in this case or to submit a trust fund account statement for the six-month period immediately preceding his release from prison, so that he can be assessed an initial partial payment of the filing fee. The other three petitioners have submitted trust fund account statements as requested. Each

understands that the Court of Appeals for the Seventh Circuit has ruled that he is responsible for paying a full filing fee under the 1996 Prison Litigation Reform Act. Boriboune v. Berge, 391 F.3d 852, 856 (7th Cir. 2004).

Accordingly, IT IS ORDERED that

- 1. Petitioner Efrain Campos is assessed \$11.40 as an initial partial payment of the \$150 fee for filing his case. He is to submit a check or money order made payable to the clerk of court in the amount of \$11.40 on or before March 18, 2005. If, by March 18, 2005, petitioner Campos fails to make the initial partial payment or show cause for his failure to do so, he will be held to have withdrawn from this action voluntarily.
- 2. Petitioner Anthony Stevens'El is assessed \$2.73 as an initial partial payment of the \$150 fee for filing his case. He is to submit a check or money order made payable to the clerk of court in the amount of \$2.73 on or before March 18, 2005. If, by March 18, 2005, petitioner Stevens'El fails to make the initial partial payment or show cause for his failure to do so, he will be held to have withdrawn from this action voluntarily.
- 3. Petitioner Souvannaseng Boriboune is assessed \$5.02 as an initial partial payment of the \$150 fee for filing his case. He is to submit a check or money order made payable to the clerk of court in the amount of \$5.02 on or before March 18, 2005. If, by March 18, 2005, petitioner Boriboune fails to make the initial partial payment or show cause for his

failure to do so, he will be held to have withdrawn from this action voluntarily.
