Plaintiff Patrick Fitzgerald is proceeding in this civil action <u>pro se</u> and <u>in forma</u> <u>pauperis</u>. In an order dated June 18, 2007, I denied plaintiff's motion for a preliminary injunction and for a medication examination pursuant to Fed. R. Civ. P. 35. In addition, I rescheduled the preliminary pretrial conference to July 10, 2007, to allow the court time to locate counsel who would be willing to assist plaintiff in this case. Now Daniel Prince, a lawyer with the law firm of Paul, Hastings, Janofsky & Walker, LLP, has agreed to represent plaintiff, with the understanding that he will serve with no guarantee of compensation for his services. It is this court's intention that the appointment of Mr. Prince to represent plaintiff extend to proceedings in this court only.¹

Plaintiff should be aware that because I am appointing counsel to represent him, he may not communicate directly with the court about matters pertaining to his case. He must work directly with his lawyer and permit him to exercise his professional judgment to determine which matters are appropriate to bring to the court's attention and in what form.

ORDER

IT IS ORDERED that Daniel Prince is appointed to represent plaintiff in this case. The record of the case will be scanned and transmitted electronically to Mr. Prince within the next few days so that he can familiarize himself with that record in advance of the pretrial conference scheduled to be held telephonically before United States Magistrate Judge Stephen Crocker on July 10, 2007. The purpose of the conference will be to set a trial date and witness disclosure and dispositive motions deadlines so that this case may proceed

steadily to resolution.
