On April 6, 2012, Larry Johnson, counsel for plaintiffs, filed a motion for leave to withdraw from his representation of plaintiffs Robert Dabal, Lewis Tate, Eula Sheehan (as

real party in interest for the Estate of Thomas Daly) and Ethel McNamara (as real party in interest for the Estate of Michael McNamara) on the ground that each has failed to respond to counsel's numerous attempts to engage in the communication necessary to pursue their claims in this lawsuit.

In an order entered on April 12, 2012, I gave plaintiffs until April 26, 2012 in which to contact the court to oppose counsel's request to withdraw and to show cause why their case should not be dismissed for failure to prosecute. On April 26, 2012, the order mailed to plaintiff Ethel McNamara was returned to the court as undeliverable by the post office. Plaintiffs Robert Dabal, Lewis Tate, Eula Sheehan (as real party in interest for the Estate of Thomas Daly) did not respond in any manner. Because plaintiff McNamara failed to keep counsel and the court advised of her current address and because the remaining plaintiffs did not respond in any way to the April 12, 2012 order, I conclude that they do not object to counsel's withdrawal from representation, I will grant the motion to withdraw and, as I warned plaintiffs I would do in the April 12, 2012 order, dismiss the case as to each named plaintiff for failure to prosecute under Fed. R. Civ. P. 41(b).

#### ORDER

IT IS ORDERED that Larry Johnson is granted leave to withdraw as counsel for plaintiffs Robert Dabal, Lewis Tate, Eula Sheehan (as real party in interest for the Estate of

Thomas Daly) and Ethel McNamara (as real party in interest for the Estate of Michael McNamara).

IT IS FURTHER ORDERED that the claims of plaintiffs Robert Dabal, Lewis Tate, Eula Sheehan (as real party in interest for the Estate of Thomas Daly) and Ethel McNamara (as real party in interest for the Estate of Michael McNamara) are dismissed with prejudice for plaintiffs' failure to prosecute them.
