(1) Statement of the case. This is a civil lawsuit brought by the plaintiff, Gerald Bushmaker, against the defendant, Rapid American Corporation. Mr. Bushmaker used to work as a pipefitter for Consolidated Paper at its Consoweld Division in Wisconsin Rapids. Later, Mr. Bushmaker got lung cancer. Mr. Bushmaker contends that as a pipefitter for Consolidated Paper, he was exposed to various products containing the mineral asbestos that were manufactured by Philip Carey Manufacturing Company, a corporate predecessor of defendant Rapid American Corporation, and that this exposure was a cause of his lung cancer.

Mr. Bushmaker contends that Rapid American Corporation manufactured or supplied an unreasonably dangerous product without providing necessary warnings, and acted negligently by failing to warn him about the health hazards of asbestos, by failing to investigate or test for those health effects and by failing to instruct him or his employers on how to take precautionary measures.

Defendant Rapid American Corporation denies that it manufactured an unreasonably dangerous product, denies that it was negligent, denies that its products were a cause of Mr. Bushmaker's lung cancer and denies that it is liable for his injuries.

Have any of you heard of this particular case before today?

- (2) The trial of this case will begin today, March 4, 2013, and could last two weeks, through next Friday, March 15. Would any of you actually be unable to serve as a juror during this time?
- (3) Asbestos background questions: During this trial, you will hear evidence about the nature and properties of the mineral asbestos, the uses to which asbestos was put in the past, and the health risks that are now associated with exposure to [certain amounts of] asbestos.
 - (a) Do any of you believe that all products containing any amount of asbestos are unsafe, or that any exposure to any amount of asbestos will cause injury or cancer?
 - (b) Do any of you believe that any and every company that at any time manufactured or sold products containing asbestos acted wrongfully and should be held responsible?
 - (c) Do any of you feel that big companies in general do not care enough about the safety of their products?
 - (d) Has anyone done research on the internet about asbestos disease?

- (e) Is there anything else about the nature of this case that would affect your ability to be fair and impartial to both sides?
- (4) Ask the lawyers for each side to tell the jury where they practice law and with whom. Ask panel whether anyone knows counsel or their law firms.
- (5) Ask plaintiff's lawyers to introduce their client briefly. Ask venire panel whether anyone knows Mr. Bushmaker.

Ask defendant's lawyers to introduce their client, the nature of their client's business, its major subsidiaries or parent corporation and where it conducts business. Ask whether anyone on the panel owns stock, has had business dealings, or has been employed by any of these entities.

- (6) Ask whether anyone on the panel owns stock, has had business dealings, or has been employed by Consolidated Paper or Consoweld.
- (7) I am going to read a list of manufacturers, sellers and miners of asbestos whose products may be mentioned or involved in this case. If you own stock in any of these companies, or if you are aware of any relatives or close friends who work for these companies, please raise your hand and I will follow up with you:
