The court held a telephonic conference today to set pretrial deadlines and a trial date for the remaining claim in this action against defendant Karen Fenkell. At the parties' request, the deadline to respond to the court's proposed entry of judgment pursuant to Fed. R. Civ. P. 54(b) was extended. In light of Karen Fenkell's request for

additional time to respond to discovery and certain court holidays, the deadlines for expert disclosures and summary judgment below have been adjusted slightly from those discussed during the conference. Accordingly,

IT IS ORDERED that:

- 1) On or before December 31, 2013, the parties shall submit briefs responding to the court's proposed entry of judgment pursuant to Fed. R. Civ. P. 54(b); and
- 2) The following deadlines govern the remaining claim against Karen Fenkell:
 - a. October 30, 2013: plaintiffs to serve written discovery requests;
 - b. November 29, 2013: Fenkell to serve written responses to discovery *and* all responsive documents;
 - c. On or before December 13, 2013: Karen Fenkell's deposition;
 - d. December 20, 2013: disclosure of both parties' experts;
 - e. December 20, 2013: dispositive motion deadline;
 - f. January 10, 2013: disclosure of responsive experts, if any;
 - g. January 10, 2013: responses to any dispositive motions;
 - h. January 17, 2013: close of discovery;
 - i. January 21, 2013: replies to any dispositive motions;
 - j. February 28, 2014: proposed findings of facts and conclusions of law for court trial;
 - k. March 6, 2014 at 3:00 p.m.: final pretrial conference; and
 - l. March 10, 2014 at 8:30 a.m.: court trial.
