On August 9, 2012, I dismissed the complaint filed by plaintiff Khor Chin Lim as frivolous and malicious because the allegations repeated those that have been dismissed previously by this and other courts. In that same order I denied a motion to consolidate this

case with several other complaints filed previously by plaintiff and I warned him that he would face sanctions, including monetary penalties, if he continued to file complaints that contained claims that he has made previously in other suits or claims that are frivolous. In spite of this warning, Plaintiff has filed another motion to consolidate this case with several other actions, dkt. # 10, and he has filed an amended complaint, dkt. # 14. Plaintiff also has filed a motion for a temporary restraining order to enjoin Mitt Romney from attending the 2012 Republican National Convention or running in the presidential election and he asks the court to freeze bank accounts belonging to Romney and Governor Scott Walker, dkt. # 15. In addition, plaintiff has filed a motion for the U.S. Marshal to serve the defendants with his pleadings in this case, dkt. # 19.

First, I note that plaintiff's amended complaint repeats all of his previous allegations with the addition of new conspiracy claims against Romney and Walker. Plaintiff now asserts that Romney and Walker caused the theft of his proof of insurance at the Winall EZ Inn in Santa Monica, California, and caused plaintiff to receive a citation following a car accident on September 29, 2011. These unlikely allegations do not cure any of the defects identified in the dismissal order entered on August 9, 2012, and are factually frivolous. Denton v. Hernandez, 504 U.S. 25, 32-33 (1992).

Second, I will not address the other motions filed by plaintiff, which are also frivolous and irrational in character. I have no doubt that defendant believes the things he is alleging, but from a neutral perspective, the allegations have no possible merit. It is not possible to believe that a presidential candidate and a governor of Wisconsin would be taking steps to

inconvenience plaintiff in Santa Monica, California. This court does not have the time or

resources to spend time on allegations like these when there are so many other litigants with

cases that deserve attention. McCready v. eBay, Inc., 453 F.3d 882, 892 (7th Cir. 2006).

In conclusion, plaintiff has not paid attention to the warning that he would be

sanctioned if he continued filing meritless complaints and claims in this case. In the future,

any motions, complaints or other materials he files will be sent to chambers for review,

without docketing. If they seem to have any plausible merit, they will be addressed. If not,

they will be retained but the court will take no action on them.

ORDER

IT IS ORDERED that

1. Plaintiff Khor Chin Lim's motions to consolidate, dkt. #10, for a temporary

restraining order, dkt. #15, and for service by the U.S. Marshal, dkt. #19, are

DENIED.

2. With the exception of any properly filed notice of appeal, all future filings by

plaintiff will be sent directly to chambers for review.
