VERIFIED COMPLAINT

JD

I. Jurisdiction : Venue

1) This is a civil action authorized by 42 U.S.C. Section 1983 to redress the deprivation, Under Color of State Law, of rights secured by the Constitution of the United States. The Court has jurisdiction Under 28 U.S.C. Section 1331 and 1333 (2)(3). Plaintiff seeks declaratory relief pursuant to 28 U.S.C. Section 2201 and 2202. Plaintiff's claims for Injunction relief are - authorized by 28 U.S.C. Section 2283 & 2284 and Rule 65 of the Federal Rules of Civil Procedures.

2) The United States District Court for the Western District of Wisconsin, is an appropriate venue Under 28 U.S.C. Section 1331 (b)(2) because it is where the events giving rise to this claim occurred.

II. Plaintiff's

3) Plaintiff, Walker, Lamont, is and was at all times mentioned herein a prisoner of the State of Wisconsin in the custody of the Wisconsin Department of Corrections. He is currently confined in Wisconsin Secure Program Facility, in Baraboo, Wisconsin.

III. Defendants.

- 1.) Defendant, Doctor Burton Cox is and was a medical Doctor of the Department of Corrections who, at all times mentioned in this Complaint, held the rank of medical Doctor and was assigned to Wisconsin Secure Program Facility.
- 2.) Defendant, Tonya Anderson is a Registered Nurse of the Department of Corrections who at all times mentioned in this Complaint, held the rank of Registered Nurse / Special Needs Committee and was assigned to Wisconsin Secure Program Facility.
- 3.) Defendant, Velinda Waterman is a Registered Nurse / Health Service Manager of the Department of Corrections who at all times mentioned in this Complaint, held the rank of Registered Nurse / Health Service manager / Special needs Committee and was assigned to Wisconsin Secure Program Facility.
- 4.) Defendant, Carrie Sotter is a Business Office Assistance / Health Service Special needs Committee of the Department of Corrections who at all times mentioned in this Complaint, held the rank of Business Office Assistance / Health Special needs Committee and was assigned to Wisconsin Secure Program Facility.
- 5.) Defendants, Joni, Shannen - Sharpe is a Lieutenant / Health Special needs Committee of the Department of Corrections who at all times mentioned in this Complaint, held the rank of Lieutenant / Health - Special needs Committee and was assigned to Wisconsin Secure Program Facility.

9.) Defendant, Jerry Sureney, is and was a Security Director / Special needs Committee of the Department of Corrections who at all times mentioned in this Complaint, held the rank Security Director / Special need Committee and was assigned to Wisconsin Secure Program Facility.

10.) Each defendant is sued individually and in his / her Official Capacity. At all times mentioned in this Complaint each defendant acted under Color of State Law.

III. Facts.

11.) To this the best of my knowledge and belief in 2011-2012, I Lament Walker, Complained Verbally to several Registered Nurses and Doctor Burton Cox that the Segregation mattress are giving me serious back pain and that I need an extra mattress to alleviate the Chronic Pain I am having. This request was denied for a very long time Subjecting me to suffer.

12.) As this pain continued throughout my stay, I continued to request for an extra mattress for my medical condition because I was in Segregation and prisoners / inmates are being restricted from certain medical addresses, was not "One-time" (to the best of my knowledge and belief) referred to any "Special needs Committee", due to the impression of it not being One established here at The Wisconsin Secure Program Facility (2010-2013).

13.) To the best of my knowledge and belief from 2011-2013 possibly 2014, Doctor Burton Cox assessed me and stated, "you do have a lot of stiffness in the mid-lower portion of your back," I explained to Doctor Cox that, "the mattress I have is hard and regardly it feels like I am sleeping on concrete." He (Cox) did

not recommend nor attempt to provide me with a medical restriction for an extra mattress (in which he can, but refuses to provide an extra mattress) or any other instruments to alleviate my chronic back pain. Doctor Burton Cox Ordered physical therapy and physical therapy also acknowledges that I have "Chronic Back Pain" and that the home-based-exercises are not improving my condition.

14.) I continued to have these "severe pains" shoot through my mid-lower back from consuming these extra, hard, concrete-like mattresses in Segregation. By Doctor Burton Cox Deliberately Disregarding the facts (based off his diagnosis which "mandated" treatment and subjected me to Chronic pain) of me needing an extra mattress and Other medical restriction, while in Segregation, demonstrated Deliberate Indifference to my serious medical needs.

15.) I, Lamont Walker, continued to request medical restrictions and all of a sudden my requests are being referred to some "Special needs Committee" which consists of medical staffs and non-medical staffs.

16.) To the best of my knowledge and belief, I was kept on the "Special needs Committee" for approximately 3 mos. or more just to be denied by majority of non-medical staffs who have no medical credentials to make a sound judgment on who qualifies for medical restriction / medical Treatment. These non-medical staffs are; (1) Jerry Sweeney (Security Director), (2) Carre Sitter (Business office Assistant), and (3) John Shannon - Sharpe (Security Administrator / Lieutenant).

17.) By these non-medical staffs making inherently, sound decisions subjects

me to Suffer in Chronic Pain, because I was denied by this "Special needs Committee" pros, provided a policy (that they use to justify their reasons for - denint) that Seized to exist in the Institutions law library or it's restricted from prisoners /Inmates reviewal. Also, they demonstrated Deliberate Indifference to my Serious medical On several Occasions, to my Knowledge and belief.

18.) The actual medical Staff's that does have medical Credentials Conspired against me with the non-medical Staff's to punishment, Cruelly and Unusually and Subject me to Suffer in Chronic Pain, when they should have prohibited these non-medical Staff's the Opportunity to over-ride the Health Service manager (Jolinda Waterman) who manages the medical Unit and the registered nurse (Sonya Anderson) decision On approving me of an extra mattress, ICE-Bag, Back Brace etc. to treat my Chronic Back Pain.

19.) On September 8th 2015 I, Lamont Walker, sent an "Informal Correveree" to the Health Service manager (Jolinda Waterman) stating Verbatim as followed:

- (1) As a Health Service Manager, your duties are to manage the Health Department and declare that "Prisoners receives adequate - medical Treatment."
- (2) "Special needs Committee", The medical Staff's and non-medical Staff's are "Deliberately" making inadequate decisions to whom and what prisoners are eligible for certain medical treatments as well as medical restriction. The non-medical Staff are not medical Graduates or have "Professional medical Knowledge" to say whether or not "Prisoners" are required, let alone qualities for medical restriction which is Unconstitutional. The "medical Staff's & Health Service manager or doctors are to make those

Kind of medical decisions:

(3) "Health Service Manager", so, by you permitting these "non-medical staff's" to decide such medical treatment (requires) shows demonstrates your Cruel & Unusual Punishment by Subjecting me to suffer in pain and Deliberate Indifference to my serious medical needs by not approving of an extra mattress, ICE Bag, Back Brace, message - Therapy and multiple other required medical restriction / treatment, as well as providing a Health Service Policy Procedure (300:07) that does not exist in the Institutions (law library).

- 20.) The Health Service manager (Dolinda Waterman) refuses to address the concerns and continues to deprive me of these "Basic necessities" of medical treatment. There's "no" medical Doctor assigned to the Wisconsin Secure Program Facility leaving all inmates / prisoners to suffer in great deals of pain.
- 21.) The Chronic back pain causes me serious discomfort to where it's hard for me to lie on my stomach and side. It causes me stiffness and immobility, when I go to pick something up off the ground my spine and muscles in my back begins to pop, and ache due to not being provided with the basic necessities to treat my medical condition.
- 22.) So, by the medical staff allowing the non-medical staff to decide medical Qualifications On or for medical restriction and treatments demonstrates the Conspiracy of Deliberate Indifference to serious medical need and Subjections to Cruel & Unusual Punishment, and pain and suffering.

23.) Defendant, Doctor Burton Cox is and was the initiator of subjecting me to suffer in pain from his demonstration of Deliberate Indifference to my Serious medical need and punished me by refusing me an extra mattress and other medical restriction and delaying the process by putting it off on the "Special needs Committee" that consist of non-medical Staff's that are not medical experts, or have medical credentials to ~~properly~~ judge whether a prisoners qualifies for any type of medical restrictions / - Treatment.

24.) The non-medical Staff's (defendants) plays a crucial role in Subjecting me to suffer in pain as well; defendants; Jerry Sweeney (Security - Director), Carrie Siffer (Business Office Assistance), and Jonie Shannon- Sharpe (Security Administrator / Lieutenant) which demonstrates Cruel - Unusual Punishment. And the medical Staff's that played and acted On the "Special needs Committee" demonstrated Deliberate Indifference to a Serious medical need and Cruel Unusual punishment by "allowing the non-medical Staff's" to Over-ride their decisions. - When it's suppose to be "Strictly medical Staff's".

IV. Legal Remedies.

25.) Plaintiff, Lamont Walker, Used the prisoner grievance procedure - available at The Wisconsin Secure Program Facility to try and solve the program / Problem. "All legal remedies are now exhausted."

V. Legal Claims.

(2a) (A) Cruel & Unusual Punishment:

Plaintiff, By the non-medical staff's acting as part of the "Special needs Committee", (Jerry Sweeney, Carrie Ditter, Jonne - Shannon - Sharpe) Subjects me to being tortured by their gross, inherently decisions On revering the proper treatment required medically. By the non-medical staff's acting On and as part of the "Special needs Committee", it Subjects me to being "punished - Cruelly & Unusually," to Suffer in pain and also being provided none existing health policies : procedures. Which Constitutes an 8th Amend. violations.

(27.) (b) Deliberate Indifference to a Serious medical need:

On several Occasions I have made several attempts to have my medical issue (Agonizing Back pain) addressed by nurses ; Doctor Cox here at the Wisconsin Secure Program Facility, but I am being disregarded in such a way. Prior to 2014-2015 I've made verbal attempts to obtain an extra mattress to alleviate my serious back pain, but was steadily being disregarded by nurses ; Doctor with long periods of delays of / by references to "Special needs Committee" which is up to their discretion by being Deliberate Indifference to my medical needs, extras mattresses etc.

By the demonstration of the Special need Committee (medical staffs ; non-medical staffs) Deliberate indifference and bluntly disregarding my medical condition Constitutes an 8th Amend. Violation and Subjected me to Suffer in pain.

VI. Prayer Of Relief

28.) Wherefore, Plaintiff respectfully prays that this Court enter

judgment granting plaintiff's:

- 29) A declaration that the acts and Omissions described herein violated plaintiff's rights under the Constitution and laws of the United States.
- 30) Plaintiff, Lamont Walker, seeks \$25,000⁰⁰ for each United States Constitutional violated.
- 31) Compensatory damages in the amount of \$100,000⁰⁰ against each defendant, jointly and severally.
- 32) Punitive damages in the amount of \$100,000⁰⁰ against each defendant.
- 33) A jury trial on all issues triable by jury
- 34) Plaintiff's costs in this suit
- 35) Any additional relief this Court deems just, proper, and equitable.
